Common Purpose is guilty of defrauding YOU of YOUR money.

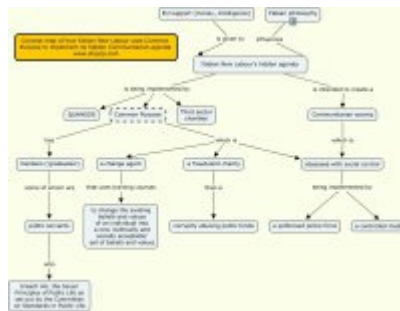
### Definitions

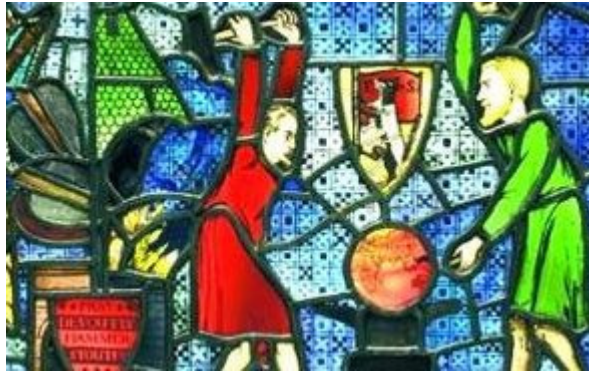

## COMMON PURPOSE METHODS



The methods used by Common Purpose are what you would expect from Euro communists in this Jigsaw of Deception.

The use of political correctness for social control and mental manipulation, deceit, fraudulent agenda, corrupt abuse of public funds, obsessive control freakery, secrecy and bland, banal and meaningless statements.

Many of the methods used by Common Purpose originated at the Tavistock Institute.

### Trojan Mice

Although Common Purpose is a 'Trojan Horse' operation, some of its methods have been more akin to 'Trojan Mice'. Trojan Mice operations have their roots in complex adaptive systems and Chaos Theory. (Please do a Web search for 'Trojan Mice' to find out more.)

These systems theories get a bit complicated but it boils down to the idea that the best way to change an organisation (or a country for that matter) is by the use of small changes which very few people take any notice of at the time. These small changes increment over time to make large changes. When the large changes become apparent to the organisation's members or the general public, they may not be able to do anything about it.

It is the manipulation of consensus that has turned the three main political parties in Britain into one party all standing on the same ground. They might offer slightly different policies - and only slightly - but they are all agreed on the fundamentals and this makes elections irrelevant.

### Problem - Reaction - Solution

A classic Common Purpose/New Labour-style ruse is to decide upon an objective, create a problem and then introduce a pre-planned 'solution' to that problem. Straight from the Hegelian Dialectic - create the problem, manipulate the response, come up with the solution. Problem - reaction - solution. A solution which puts you in the position you wanted to be in in the first place but needed to create the problem in order to get there.

For example: Problem - to allow EU police into Britain unhindered. Reaction - allow EU criminals into Britain unhindered. Solution - allow EU police into Britain unhindered.

### Leading Beyond Authority

A Common Purpose quote: "People who lead beyond their authority can produce change beyond their direct circle of control".

The term 'leading beyond authority' refers to how Common Purpose deals with those people who are resistant to 'change' because of their inertia - not necessarily because they are actively hostile to Common Purpose. People whose inertia - such as the 'we've always done it like this, why do we need to change' types - are simply bypassed. Common Purpose finds it much more difficult to deal with those people who are actively hostile to them.

Leading beyond authority can mean acting ultra vires. Ultra vires a legal concept. It is

Latin for 'beyond the powers'. It can apply to any body which has rules, such as a charity or a local authority. An ultra vires act is one that is outside the specified and/or implied constitutional objects and powers of the body in question. It is 'beyond the powers' and therefore illegal.

Also, what are the implications of 'leading beyond authority' for services which require a hierarchical management structure to ensure discipline and cohesion, like the armed forces and police which can be manipulated from within for political purposes?

Common Purpose 'graduates' are incapable of leading by example because those people who have found out what they are up to do not trust them at all.

## COMMON PURPOSE MEMBERS ('GRADUATES')



The main way that Common Purpose is subverting Britain is by infiltrating their 'graduates' into managerial positions of power in national and local government, the media, the NHS, the military, the police and the judiciary.

Common Purpose needs these 'graduates' to run the social control bureaucracy of the British regions of the European Union in what they call the

'post-democratic' society.

People become Common Purpose 'graduates' for career advancement and to be part of a secret, Masonic-like society for careerists who want what Common Purpose has to offer - access to the corridors of power.

The term 'graduate' is used deliberately so as to prevent disclosure of involvement with Common Purpose. As 'member' of Common Purpose, which is more appropriate, individuals in the public sector would have to declare their interests.

Common Purpose creates the illusion that it is for ordinary people, but it is run by an élite for an élite. You do not become a Common Purpose 'graduate' unless you are in the right job, have the right influence and conform to the politically-correct Common Purpose collective mindset. In order to qualify as a Common Purpose 'graduate', candidates have to pass the Common Purpose 'correct thinking' schemes.

There is a strong resistance amongst Common Purpose 'graduates' towards giving out details of their Common Purpose membership and the activities they engage in. Common Purpose operates according to the Chatham House rules which means that meetings are held in secret with no agenda, records or accountability.

How to Find Common Purpose Members ('Graduates')

You can make Freedom of Information (FOI) requests online free, gratis and for nothing [here](#).

If the people you want to find out about are employed by a public body, you could try making a Freedom of Information (FOI) request to the body they work for asking specifically if Mr X has ever attended a Common Purpose training course, or if they are probable celebrities, check celeb fan blogs like [showbuzzgurl](#) for some information. Also ask if they are a Common Purpose 'graduate', when they attended the course, how much the courses they attended cost and who paid. You might strike lucky.

You can simply ask for a list of members of that organisation who are Common Purpose 'graduates'. You might get lucky or you might get a "we don't keep those records centrally and it will cost too much to find out" type of answer.

It is a good idea to explain what Common Purpose is because some of the people who handle these FOI requests appear not to know, so you can say something like "By Common Purpose, I mean the training organisation of that name: <http://www.commonpurpose.org/home.aspx> By Common Purpose 'graduate', I refer to a specific class of person who has passed the advanced Common Purpose courses."

If you do not get a reply...

If they do not reply to you within 20 working days - i.e. about a month, I suggest you do two things:

1. Write to them again and ask for an internal review of the request
2. Complain to the Information Commissioner's Office [here](#) or write to them [here](#).

Here is a sample request:

b. to the Norfolk Constabulary who refuse to provide the names CP graduates but provide expenditure details:

The get-out clause is:

"Under Section 40(2) of the Freedom of Information Act (2000), personal information is exempt from disclosure if such a disclosure would breach any of the principles laid down under the Data Protection Act (1998). The first Principle of the Data Protection Act (1998) states that:

"Personal data shall be processed fairly and lawfully, and, in particular shall not be processed unless

- (a) at least one of the conditions in Schedule 2 is met, and
- b) in the case of sensitive personal data, at least one of the conditions in Schedule 3 is also met."

In this case, members of the Constabulary have undertaken training courses provided by "Common Purpose" for reasons of personal development, and not as a requirement to perform their role as members of the Constabulary. Disclosure of the information you have requested does not meet any of the conditions of Schedule 2, also members of the Constabulary would have no expectation that their names would be published, and therefore to do so in response to a Freedom of Information request would be unfair to those individuals. Under Section 17 of the Freedom of Information Act (2000) this serves as a refusal notice for this aspect of your request, by virtue of the application of Section 40(2) of the Freedom of Information act (2000)."

Note: Any civil servant or policeman who undergoes training at the cost of the taxpayer can only do so if it is of benefit to the taxpayer, i.e. as a part of their public service function. If a public authority uses public money for private development then it is breaking the law. Common Purpose often uses the excuse of 'personal development' when referring to the activities of its members, especially when the actions of those members impacts financially upon the taxpayer. This argument is specious.

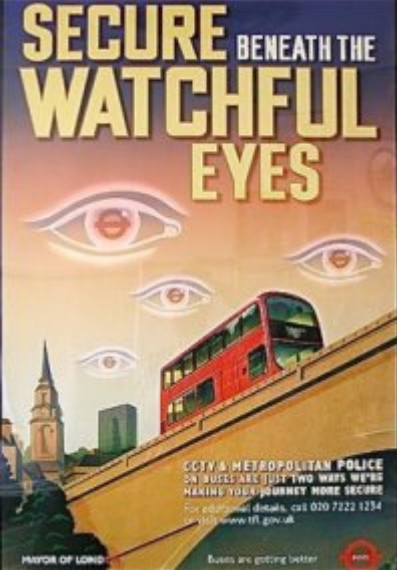

Common Purpose operates according to the Chatham House rules which effectively means that meetings are held in secret with no agenda, records or accountability. Why are public servants allowed to attend these unaccountable meetings and training courses?

#### 5. Openness

Holders of public office should be as open as possible about all the decisions and actions that they take. They should give reasons for their decisions and restrict information only when the wider public interest clearly demands.

There is a strong resistance amongst Common Purpose 'graduates' in public office towards giving out details of their Common Purpose membership and the activities they engage in. Common Purpose itself operates according to the Chatham House rules which effectively means that meetings are held in secret with no agenda, records or accountability. Hardly a recipe for 'Open Government'.

Just why are Common Purpose and some public bodies, such as some police forces, so frightened of the public finding out who their Common Purpose members are and what takes place on Common Purpose training courses by hiding behind Chatham House Rules and Freedom of Information exemptions? What has happened to probity?

There is very strong resistance by some public bodies towards giving out information requested in Freedom of Information requests about their dealings with Common Purpose.

Here are some of the methods some public bodies use to avoid disclosure of information under Freedom of Information (FOI) requests:

##### I. Section 40(2) of the Freedom of Information Act (2000)

Here is an example of identical requests made to different constabularies:

a. to the Devon and Cornwall Constabulary who provided names of Common Purpose graduates and expenditure on Common Purpose courses

III. Asking about individuals

If Common Purpose has nothing to hide, if Common Purpose is not sinister, then why do organisations keep from the public the names of persons who have attended Common Purpose courses? What have they to hide?

6. Honesty

Holders of public office have a duty to declare any private interests relating to their public duties and to take steps to resolve any conflicts arising in a way that protects the public interest.

Many Common Purpose 'graduates' in public service deliberately hide their membership of Common Purpose. This leaves them open to accusations of dishonesty, corruption, favouritism and under-the-counter dealings. Common Purpose targets the grey areas where public and private bodies meet such as Local Strategic Partnerships. These are prime candidates for potential corruption and dishonesty.

Common Purpose 'graduates' are masters of deceit and doublespeak.

7. Leadership

Holders of public office should promote and support these principles by leadership and example.

A Common Purpose quote: "People who lead beyond their authority can produce change beyond their direct circle of control".

Leading beyond authority can mean acting ultra vires. Ultra vires a legal concept. It is Latin for 'beyond the powers'. It can apply to any body which has rules, such as a charity or a local authority. An ultra vires act is one that is outside the specified and/or

implied constitutional objects and powers of the body in question. It is 'beyond the powers' and therefore illegal.

Also, what are the implications of 'leading beyond authority' for services which require a hierarchical management structure to ensure discipline and cohesion, like the armed forces and police which can be manipulated from within for political purposes?

Common Purpose 'graduates' are incapable of leading by example because those people who have found out what they are up to do not trust them at all.
